

TERMS AND CONDITIONS

Effective Date: September 25th 2023

Welcome to New Noise, an events and ticketing website ("Platform") operated by New Noise Pty Ltd ("New Noise", "we", "us", or "our"). These Terms & Conditions ("Terms") govern your access to and use of the Platform, its features, services, and any associated content. By accessing or using the Platform, you agree to be bound by these Terms. If you do not agree with any portion of these Terms, please do not access or use the Platform.

- 1. Account Registration and Security:
- 1.1 You must be at least 18 years old to create an account on our Platform. By creating an account and using the Platform, you represent and warrant that you are of legal age to form a binding contract.
- 1.2 You agree to provide accurate, current, and complete information during the registration process. It is your responsibility to keep your account information updated.
- 1.3 You are solely responsible for maintaining the confidentiality and security of your account credentials. You agree to notify New Noise immediately of any unauthorized access or use of your account.
- 1.4 New Noise reserves the right to suspend or terminate your account if any information provided is found to be false, misleading, or in violation of these Terms.
- 2. Events and Ticketing:
- 2.1 New Noise partners with Oztix and TicketMaster Australia to sell tickets to events listed on our Platform. All ticket sales are governed by their respective terms of service and privacy policies.
- 2.2 New Noise endeavors to provide accurate and up-to-date information about events and ticket availability. However, we do not guarantee the accuracy, completeness, or availability of event listings, including ticket pricing, event dates, or venue details. Changes or cancellations may occur, and we encourage you to verify event details independently.
- 2.3 Any grievances related to event cancellations, refunds, or disputes arising from ticket purchases must be resolved directly with the ticketing partner from whom you purchased your ticket.
- 3. Use of the Platform:
- 3.1 You agree to use the Platform only for lawful purposes and in compliance with all applicable laws and regulations.
- 3.2 You may not use the Platform for any malicious, fraudulent, or harmful activities, including but not limited to hacking, unauthorized access, data scraping, or any activity that interferes with the proper functioning of the Platform or its services.

3.3 New Noise reserves the right to suspend, terminate, or restrict your access to the Platform, without notice, if we believe you have violated any provision of these Terms or engaged in illegal or unauthorized activities.

4. Intellectual Property:

5. Limitation of Liability:

- 5.4 New Noise's liability for any claim arising out of these Terms or your use of the Platform will be limited to the amount you paid to New Noise, if any, during the six-month period preceding the claim.
